Dear Parents/Guardians, current and new learners of 2025

- 1. We would like to express our appreciation for your support of the school. Without such loyal parent/guardian support, De Kuilen would not be able to maintain its proud tradition.
- 2. The meeting with the governing body and the parents where the budget for **2025** was discussed and approved, was held on Wednesday, 30 October 2024. Unfortunately, not all parents/guardians were able to attend, but we do appreciate the regular, faithful financial support we receive from the majority of the parents/guardians.
- 3. During the aforementioned meeting of Wednesday, 30 October 2024 school fees totaling R25 300 per learner for 2025 were approved. It remains our school's aim to provide our learners with education of the best possible quality, which is why it is of the utmost importance that school fees be settled punctually. Without this, the school cannot function effectively and teaching would be curtailed as almost half of the staff is financed by means of school fees, since the Department of Education makes only partial financial provision for the school.
- 4. To accommodate parents/guardians, the following options of payment were also approved at the meeting of Wednesday, 30 October 2024:

Every learner must each pay R1 000 school fees by no later than 24 January 2025 (at the very latest).

- 1. De Kuilen High School strives to offer the best quality education to all learners. In order for the school to meet its financial obligations, the prompt payment of school fees is essential.
- 2. Both parents/the guardian(s) of every learner bear the responsibility for the payment of school fees for 2025. Should you not pay the full amount owed or miss out on payments before 03 November 2025, the governing body of De Kuilen High School will have the right to refer the full amount owed for 2025 to a debt collector. In this case you would be liable to pay the amount owed to the school for 2025 and if legal proceedings were to be instituted against you all costs, including tracing fees, collection commission on the amount referred, as well as all legal costs on an attorney- and client scale plus interest at 11.75%.
- 3. If you prefer to pay in monthly installments, each installment is payable in advance for every month commencing on 03 February 2025 and ending on 03 November 2025.
